JBR Capital Highland Hoon Tour Prize Draw

Terms & Conditions

ENTRY CRITERIA

1. Entry into this prize draw will be deemed acceptance of these rules
2. Entries are limited to one entry per person. Use of a false name or email address will disqualify the selected entrant from receiving any prize.
3. The prize draw organiser reserves the right to ask any potential winner for documented proof to verify their identity.
4. No cash alternative will be available and all prizes are non-transferable and non-negotiable
5. Employees (including contractors) and their immediate family members of the prize draw organiser and/or any other company in the Shawbrook Group of companies are prohibited from entering the prize draw.

THE PRIZE

A place on the Highland Hoon Tour for you and a guest to be held 12 to 16 October 2026.

Accommodation is included between 12 to 16 October as part of the prize but no other expenses will be covered by the prize draw organiser as part of the prize unless explicitly stated. All entrants must be aged 25 years or over to enter and if you are a winner of the prize your chosen guest must also be aged 18 years or over for the duration of the tour.

If required, a hire vehicle (Lotus Emira V6 or similar) will be provided, subject to the winner meeting the hire company's insurance and eligibility requirements. The cost of hire of the vehicle and insurance will be included as part of the prize and paid for by the prize draw organiser.

Supercar Driver membership will be provided for the winner and guest where they are not already current members or extended for the winner and guest if they are current members but their membership would expire before or during the tour.

TERMS

1. JBR Capital is the prize draw organiser ("the Promoter"). Registered Office: Floor 10, 40 Leadenhall Street, London, EC3A 2BJ. 2. The prize draw will run from **10:00am 23 July 2026** and will end **12:00pm Sunday 23 August 2026** ("Closing Date"). The prize draw is online only and is free to enter and open to customers of JBR who are UK residents aged 25 or over at the time of entry. To enter, participants must complete the online entry form and correctly answer the prize draw question. Entrants are responsible for their normal costs of accessing the internet. Only one entry per person is permitted.

3. The winner will be selected at random by the Promoter (or using an independently supervised random selection process) from all correctly answered and eligible entries received before the Closing Date. The draw will take place from **12:00pm on Monday 24 August 2026**.

4. The winner may participate in the Highland Hoon Tour using their own eligible vehicle, subject to satisfying all applicable insurance, licensing and event participation requirements. Alternatively, if the winner does not use their own vehicle, the Promoter will provide a hire vehicle (Lotus Emira V6 or similar), subject to the winner meeting the hire company's insurance and eligibility requirements. Where a hire vehicle is provided as part of the prize, it will be insured for the winner only and may only be driven by the winner. The winner is responsible for ensuring that their guest does not drive the hire vehicle. Supercar Driver membership is not required to enter the prize draw. Participation in the Highland Hoon Tour requires the winner and guest to hold a valid Supercar Driver membership covering the dates of the Highland Hoon Tour. Where the winner and/or their guest do not already hold valid membership covering those dates, the Promoter will purchase and provide the required memberships or extensions to membership as part of the prize (which will be valid for one year). The winner and their guest can unsubscribe from being a Supercar Driver member at any time by sending a request to membership@supercar-driver.com. However, it is a requirement to participate in the Highland Hoon Tour to be a Supercar Driver member for the duration of the Highland Hoon Tour. Accordingly, if the winner or guest cancels or terminates the Supercar Driver membership required for participation before or during the tour, or fails to satisfy applicable licensing, insurance, hire company or event participation requirements, they may be unable to participate in the tour. No cash alternative is available, and the prize is non-transferable and non-exchangeable.

By entering the prize draw you agree that the Promoter may use your personal data and images for these purposes and that you have, or will, obtain the necessary consent from your chosen guest ahead of participating in the prize in the event you are selected as a winner.

9. The winner must confirm acceptance of the prize within 5 working days of being contacted by the Promoter. If the winner does not respond within this period, the Promoter reserves the right to select another winner at random from the remaining eligible entries.

10. The Promoter makes no representations or warranties as to the quality/suitability of any of the goods or services offered as a prize. Except for liability for death or personal injury caused by the negligence of the Promoter, the Promoter shall not be liable for any loss suffered or sustained to person or property including, but not limited to, consequential (including economic) loss by reason of any act or omission by the Promoter, its servants or agents, in connection with the arrangement for the supply of any goods or services by any person to the winner and, where applicable, to any guest accompanying the winner.
